## IMMUNITIES AND PRIVILEGES (GLOBAL FUND TO FIGHT AIDS, TUBERCULOSIS AND MALARIA) ORDER, 2022

IN EXERCISE of the powers conferred by Section 24(1) of the Immunities and Privileges Act, I, NANCY TEMBO. Minister of Foreign Affairs, hereby make the following Order-

- 1. This Order may be cited as the Immunities and Privileges (Global Fund Citation to Fight AIDS, Tuberculosis and Malaria) Order, 2022.
- The Global Fund to Fight AIDS, Tuberculosis and Malaria (hereinafter Immunities) referred to as "Global Fund") being an organization specified in the Fourth and privileges Schedule of the Act, shall have all the immunities and privileges set out in Part and legal I of the Fifth Schedule of the Act and shall have all the legal capacities of a Global Fund body corporate.
- 3. There are hereby conferred upon such persons, not being citizens of, or Immunities permanently resident in, Malawi, as Global Fund may, in writing, to the and privileges Minister of Foreign Affairs designate by name being-

of representatives and staff of Global Fund

- (a) representatives of Global Fund or holders of such high offices of Global Fund as shall be specified in such writing, all the immunities and privileges set out in Part II of the Fifth Schedule of the Act; and
- (b) officers or servants of Global Fund of such class as shall be specified in such writing, all the immunities and privileges set out in Part III of the Fifth Schedule of the Act.
