IMMUNITIES AND PRIVILEGES (AFRICAN INSTITUTE FOR POLICY DEVELOPMENT) ORDER, 2022

IN EXERCISE of the powers conferred by section 24 (1) of the Immunities and Privileges Act, I, EISENHOWER NDUWA MKAKA, Minister of Foreign Affairs, hereby make the following Order—

1. This Order may be cited as the Immunities and Privileges (African Citation Institute for Development Policy) Order, 2022.

Immunities and privileges and legal capacity of AFIDEP The African Institute for Development Policy (hereinafter referred to as "AFIDEP"), shall have all the immunities and privileges set out in Part I of the Fifth Schedule of the Act and shall have all the legal capacities of a body corporate.

Immunities and privileges of representatives and staff of AFIDEP

- 3. There are hereby conferred upon such persons, not being citizens of, or permanently resident in, Malawi, as AFIDEP may, in writing, to the Minister of Foreign Affairs designate by name being—
 - (a) representatives of AFIDEP or holders of such high offices of AFIDEP as shall be specified in such writing, all the immunities and privileges set out in Part II of the Fifth Schedule of the Act; and
 - (b) officers or servants of AFIDEP of such class as shall be specified in such writing, all the immunities and privileges set out in Part III of the Fifth Schedule of the Act.
